Thank you for your request for information which we have dealt with under the terms of the Environmental Information Regulations 2004.

Some of the information requested is held by the City Council. In our earlier exchange of emails we explained that the County Council is the decision-making authority on this item and you explained that you have also sough disclosure of information from the County Council.

We are disclosing information where we have it however items where we hold no information are exempt and refused under the exception rules relating to EIR and I will explain which Regulation is applied to the information you have requested. The City Council does not own the land at Skaters Meadow, and the consultation and then decision to bollard the existing public footpath/ right of way is one being taken by the County Council. The City Council has supported the County with enquiries with neighbouring landowners. The ownership of the land remains unregistered.

The City Council recognises the significant importance this site has for our residents in relation to access to nature and open space and also the benefits this site has helped deliver through the Pandemic. We are therefore supporting where we can in helping to reach a decision on the use of the land in question for vehicle access.

The City Council does not propose to take any action which might be construed as an act of management, possession, or ownership in relation to the Property, since to do so may incur upon it, liabilities with which the Property is, or may become, encumbered.

You may wish to direct your enquiry to the County Council in respect of this matter, as they may be able to give you a fuller response with the information they may hold.
