4. What is the number of households with children you currently have waiting for a decision on their homelessness application? 88

5. Since 23 March 2020, how many households with children in temporary accommodation have waited for a decision on homelessness beyond 56 days? Applicants placed into temporary accommodation will almost always be owed a 56 day relief duty. The decision on the main homelessness duty is made at the end of this 56 day relief period, and only if the homelessness wasn't successfully relieved during this time. In other words, it's standard practice for households in temporary accommodation to be issued with a decision on the main homelessness duty beyond 56 days. A decision on the main duty will not be issued before then. 6. For those households with children who are currently living in temporary housing, what is the average time they have spent in temporary housing so far? 192

7. For those households with children who are currently living in emergency housing, what is the average time they have spent in emergency housing so far? This relates to the answer to Q8 below and the household in the hostel has been there since 3 February and the Bed and Breakfast households have been there since 1 October. I calculate this as an average of 87 days rounded to the nearest day for the 3 households.

8. How many households with children are currently living in emergency housing?3 - 1 in a hostel and 2 in Bed and Breakfast accommodation.

9. From 1 April 2020 to 31 March 2021, how many households with children made homelessness applications to the council? 184
