### **(CCC) Licensed Operator Details Request**

We emailed all Taxi & PHV licensing authorities on 4 May to advise that we have a significant database of UK taxi and PHV operators based on 30 years of information gathering and under General Data Protection Regulation (GDPR) and the Data Protection Act 2018, it is a requirement that this data is accurate, and where necessary, kept up to date.

Many authorities have now kindly provided considerable information following our request to electronically provide the data you hold on licensed taxi and PHV operators in your licensing authority, ideally in a spreadsheet or other similar format.

We have sent emails to [taxi@cambridge.gov.uk](mailto:taxi@cambridge.gov.uk) but to date we have not had a reply or an acknowledgment that our emails have been received. We are therefore attempting to send once again to a different email address in the hope that we are successful this time.

As Local Authorities are extremely busy, initially we requested that this data was provided by the licensing team without the need for a formal Freedom of Information request, however we still need to communicate to licensed operators on changes to taxi & PHV legislation, air quality requirements, safety and best practice throughout the UK.

We therefore now need to make this a Freedom of Information request.

This data has been provided by many responding authorities in spreadsheet formats rather than being referred to their websites, which is extremely helpful as we too have limited resources at an extremely busy time.

The data we seek is:

The Trading Name of the Operator

The Point of Contact

The Address of the Operator

A Telephone Number or Mobile for the business The Company email address The license number and expiry date This data will not be used for any commercial purposes other than communications regarding 'industry based' information. The data will also be subject to all the requirements of General Data Protection Regulation (GDPR) and the respective Data Protection and Freedom of information Acts UK wide. It will be managed securely and personally overseen by myself as the LPHCA Data Controller.

As this information is needed urgently for communications on changes to taxi & PHV legislation, air quality requirements, safety, and best practice throughout the UK, it would be greatly appreciated at your earliest convenience, ideally by return email.

As some Local Authorities have / or are becoming unitary Licensing Authorities,

please forward our email and kindly advise us where possible of updated contact emails.

We have endeavored to send this email to the principal email address in licensing, from historical and recently obtained records. If this email has not found the principal email address, would you be kind enough to forward and advise us where such communications should be sent, many thanks.
