

**Matter CC1: Protecting and Enhancing the Character of Cambridge – Supplement 2**

1. The Council's Matter CC1 Statement referred to the Playing Pitch Strategy 2015-2031<sup>1</sup> for grass and all weather pitches in Cambridge and South Cambridgeshire and an Indoor Sports Facility Strategy 2015-2031<sup>2</sup> to guide future provision of indoor sports halls, swimming pools and outdoor cycling facilities to serve existing and new communities. Cambridge City Council and South Cambridgeshire District Council, in partnership with Sport England, commissioned the strategies to address the two local authorities' needs.
2. The Playing Pitch Strategy was the subject of discussion during Day 22 of the Local Plans Examinations on 15 June 2016. This hearing session concerned Matter CC1B – Open Space and Natural Environment.
3. During the hearing session, it was suggested that, in the interest of clarity, all playing pitch sites for Cambridge (as listed in Appendix 1 of the Playing Pitch Strategy) should include their corresponding site reference as listed in the Open Space and Recreation Strategy 2011 (RD/NE/050). The Council has made these revisions. Additionally, the Council has also made a number of minor revisions to the Playing Pitch Strategy and the Indoor Sports Facility Strategy.
4. A list of changes to the Playing Pitch Strategy and the Indoor Sports Facility Strategy is provided overleaf. Deleted text is shown as struck through. New text is underlined, whilst any mapping or explanation of multiple changes is shown in italics.

Paragraph 1.3	<del>The national policy context is summarised in Appendix 1, National Level.</del> The key context factors for both the City and South Cambridgeshire are:
Paragraph 1.33	Although generally affluent, there are pockets of deprivation in the north of the City. Deprivation ranking of 227 nationally (2015) (See <u>Table 2.3 Appendix 14</u> )
Paragraph 1.34	South Cambridgeshire District has a deprivation ranking of 262 nationally (2015) (See <u>Table 2.5 Appendix 14</u> )
Paragraph 2.25	... dominant segments are Jamie, Tim and Ben ( <del>See Appendix 12 for detailed explanation of Market Segmentation</del> )
Paragraph 5.143	The Perse <u>Upper School Preparatory School</u> and the Perse <u>Upper School for Girls</u> (Independent Schools) AGPs apart from school use are used for matches by the community clubs when the pitch is available. Paragraph 5.320	<p><i>Add additional sentence to the end of paragraph 5.320 to clarify the usage of squash facilities.</i></p> <p>All the pay and play squash facilities across Cambridge and South Cambridgeshire District are located on education sites; all but Kelsey Kerridge therefore have limited day time access. <u>However, the majority of squash is played in evenings and weekends, so this is less of an issue than it is for sports hall provision.</u></p>
