# Frequently Asked Questions and Guidance on How to Respond

# What is the Land north of Cherry Hinton Supplementary Planning Document?

The Land north of Cherry Hinton Supplementary Planning Document (SPD) sets out how development will take place on Land north of Cherry Hinton. It looks at where roads and particular uses (e.g. schools) could go, and will be a material consideration when any planning application is submitted for the site.

# Why is development taking place on Land north of Cherry Hinton?

This site has been allocated for development since 2008, when the Cambridge East Area Action Plan was adopted. The Cambridge East Area Action Plan allocated the whole airport site for development, contingent on the relocation of the Airport. The site was allocated as a sustainable urban extension to the city, that would have minimal impact on Green Belt purposes and allow for development that would have maximise active mode share (walking and cycling) and public transport.

In 2010 it was announced that the airport would not relocate in the foreseeable future. Two parts of the site were recognised in the Area Action Plan as being capable of coming forward while the airport remained on the site: North of Newmarket Road and Land north of Cherry Hinton. The emerging Local Plans for Cambridge and South Cambridgeshire carry forward the allocation of Land north of Cherry Hinton as a sustainable location for development.

## Why are we consulting?

The Councils have already held workshops with local stakeholders to gather their views. The Councils now want to go out to a wider public consultation to allow for everyone else to give their views on the SPD.

# How can I have my say on the Land north of Cherry Hinton SPD?

## Data Protection

The information collected will be processed in accordance with the Data Protection Act 1998. Information from the forms will be stored on a computer database used solely in connection with the Local Plan Review. Representations will be available to view on the Council's website, although address and contact details will not be included. However, as copies of representations must be made available for public inspection, they cannot be treated as confidential and will be available for inspection in full.

## WHEN CAN I COMMENT?

Representations on the consultation documents must be submitted during the tenweek period between:

## 9am on 7 August 2017 to 5pm on 2 October 2017.

Comments received after this deadline will not be accepted.

Sending emails or replying by using the online consultation system may be difficult on the last day of the consultation as electronic services may get very busy. Please try to reply before the last day to guarantee that your reply gets to us in good time.

## What will happen to my representation?

After the end of the consultation period you will be sent an acknowledgement stating your personal identification number and the reference numbers corresponding to your representation(s). These reference numbers must be given on any future correspondence and/or when telephoning the Council. Only valid representations will be acknowledged.

## What happens next?

Once the consultation period has finished, we will analyse and consider all the responses that we receive. The Council will then make any appropriate amends to the document.

- 3. You will then need to fill in some details about yourself. This will allow the Council to keep you informed about the progress of the Local Plan Review. You will also need to create a password, which will allow you to return to the site and comment on other consultations in the future.
- 4. After you have registered, you will be taken back to the main consultation page and your name will appear in the top left of the screen. This means that you are logged into the system and are able to make representations.
- 5. To make comments on your chosen consultation document, scroll down the page to the section called "Current documents open to public participation"

- 6. You can then browse through the document on screen and when you wish to make a comment about a particular piece of text, click the pencil icon next to the text:
- 7. Then you put your comments in the box marked "Full Text of Representation." If the text of your representation is over 100 words, you will need to summarise it in the box below entitled "Representation Summary."
- 8. When you have finished, remember to click the submit button at the bottom of the page. You can then continue making more comments, repeating steps 6 and 7.
- 9. You will receive an email confirming that we have received your comments.
- 10.If you leave the site and come back to it and wish to make further representations, you will not need to register again, but you will need to log in. You will need to put your email address and password into the boxes at the top of

the page.
