

## Cambridge Local Plan Adoption Statement

Notice is hereby given in accordance Regulations 17, 26 and 35 of the Town and Country Planning (Local Planning) (England) Regulations 2012 (as amended) that the **Cambridge Local Plan 2018** was adopted by Cambridge City Council on **18 October 2018**.

The Cambridge Local Plan was submitted to the Planning Inspectorate for Examination in March 2014. This examination was conducted between March 2014 and August 2018. The Inspectors' Report concluded that, with the recommended main modifications which are set out in their report, the Cambridge Local Plan satisfies the requirements of Section 20(5) of the Planning and Compulsory Purchase Act 2004 (as amended) and meets the criteria for soundness in the National Planning Policy Framework. The adopted Cambridge Local Plan 2018 incorporates these main modifications, as well as some additional modifications that do not materially affect the policies, pursuant to Section 23 of the Planning and Compulsory Purchase Act 2004 (as amended).

Any person aggrieved by the Cambridge Local Plan 2018 may, with the leave of the High Court, make an application to the High Court under section 113(3) of the Planning and Compulsory Purchase Act 2004 (as amended) on the grounds that:

- a) the document is not within the appropriate power (as defined in section 113(9) of the Planning and Compulsory Purchase Act 2004); or
- b) a procedural requirement has not been complied with.

Any such application must be made to the High Court not later than the end of the period of six weeks beginning with the day after the date on which the Local Plan was adopted (i.e. six weeks beginning on 19 October 2018).
