THE CITY OF CAMBRIDGE (OFF STREET PARKING PLACES) ORDER 2017

This Order is made by Cambridge City Council in exercise of their powers under Sections 32, 33, 35 and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers. Cambridge City Council makes this Order in respect of all parking places referred to in this Order. Cambridge City Council makes this Order with the consent of Cambridgeshire County Council in accordance with Section 39(3) of the 1984 Act. The Chief Officer of Police has been consulted about this Order in accordance with paragraph 20 of Schedule 9 to the 1984 Act.

PART 1 GENERAL

Commencement and citation

1. This Order shall come into operation for all purposes on the 1st day of April **2017** and may be cited as The City of Cambridge (Off Street Parking Places) Order **2017**.

Definitions and interpretation

2. (1) In this Order, except where the context otherwise requires the following expressions have the meaning as hereby respectively assigned to them:

“the Act of 1984” means the Road Traffic Regulation Act 1984 (as amended);

“the Act of 2004” means the Traffic Management Act 2004 (as amended);

“access road” is the means of gaining access or egress to or from a garage forecourt parking area as designated by this Order and identified in Schedule 5 and will be included with the designation of the garage forecourt for the purposes of this Order;

“business premises” means premises which are put to any of the following lawful planning use classes specified in the Schedule to the Town and Country Planning (Use Classes) Order 1987:

- Class A1 Shops
- Class A2 Financial and professional services
- Class B1 Business
- Class C1 Hotels
- Class D2 Assembly and leisure

subject to such limitations on the uses permitted within the same class as may be specified in of the said Schedule;

“car” means any mechanically propelled vehicle with more than two wheels except commercial vehicles and includes a motorcycle with sidecar;

“car club” means a formally constituted car-sharing scheme approved of by the Council to operate within its boundaries;

“car club parking permit” means a permit issued under the provisions of Article 29 of this Order;

“car club permit holder” means a person or organisation to which a car club permit has been issued;

“car club parking place” means an area of off-street parking place designated as such by this Order;

“car park attendant” means a person authorised by or on behalf of the Council to supervise any parking place;

“charging hours” means any period specified in Schedules 6 and 7 in respect of which a charge for parking is specified;

“coach” means a mechanically propelled vehicle with 4 wheels or more and constructed for the carriage of passengers comprising more than eight seats in addition to the driver’s seat;

“civil enforcement officer” means a person authorised by or on behalf of the Council to enforce the regulations in any parking place;

“controlled hours” means the days and hours prescribed in this Order during which a vehicle may park in a car park or permit parking place in accordance with the conditions in this Order;

“Council” means Cambridge City Council in respect of all parking places referred to in this Order;

“disabled person’s badge” and “disabled persons vehicle” have the same meaning as stated in Regulation 3 of the Local Authorities’ Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000 (Statutory Instrument 2000 No 683);

“driver” means, in relation to a vehicle waiting in a parking place, the person who drove the vehicle into the parking place and/or the person who with the owner, registered keeper or principal user’s authority removes it from the parking place;

“free off-street parking place” means a parking place designated as such by this Order and identified as such in Schedule 4 to this Order;

“garage forecourt” means a parking place designated as such by this Order and includes any access road to gain entry or exit from the garage forecourt parking place, which are identified as such in Schedule 5 to this Order;

“garage parking space” means a space within a garage, excluding the garage forecourt, let to a tenant of a Council property or to any other person under a tenancy agreement;

“goods vehicle” means a motor vehicle which is constructed or adapted for use for the carriage of goods of any description, and is not drawing a trailer;

“Hackney Carriage” means a vehicle duly licensed by the Council as a Hackney Carriage pursuant to its powers under Section 38 of the Town Police Clauses Act 1847 and Section 47 of Local Government Miscellaneous Provisions Act 1976;

“invalid carriage”; has the same meaning as defined in Section 185(1) of Road Traffic Act 1988.

“maximum time limit” refers to a limit on the time that a vehicle may under this Order wait in a car park or parking area;

“motorcycle” has the same meaning as defined in Section 185(1)(c) of Road Traffic Act 1988;

“motorcycle parking place” means an area of off-street parking place designated as such by this Order;

“motorcycle combination” refers to a motorcycle as defined by this Order with a sidecar attached;

“motor vehicle” has the same meaning as stated in Section 185(1) of the Road Traffic Act 1988;

“owner” shall be taken to be the person by whom the vehicle is kept and it shall be presumed that the owner at any point in time was the registered keeper of the vehicle at that time;

“park” “parked” or “parking” refers to a vehicle which waits in a car park or parking place in accordance with the conditions of this Order;

“parking bay” means any area of a car park or parking place which is provided for the leaving of a vehicle and indicated by markings on the surface of that car park or parking place;

“parking charge” is the charge that applies when parked in a payment car park or parking place as set from time to time by the Council;

“parking device” has the same meaning as Section 35(3B) of the Road Traffic Regulations Act 1984 and shall be taken to mean either a card, disc, token, meter, permit, stamp or other similar device, whether used in a vehicle, or not, which, being used either by itself, or in conjunction with any such apparatus indicates or causes to be indicated the payment of a parking charge and the other information in relation to that parking charge as detailed in Section 35(3B)(a) and may also operate apparatus controlling the entry of vehicles to or their exit from the parking place, or enables that apparatus to be operated;

“parking place” means any parking place or parking area designated as such by this Order and which is subject to any conditions of use as determined by this Order;

“payment parking place” means any parking place designated as such by this Order where a parking charge applies to the period of waiting within the parking place;

“pay and display parking place” means a parking place designated as such by this Order and identified as such in Schedule 2 to this Order and includes forms of payments for parking that do not require a ticket to be displayed;

“pay-on-foot parking place” means a parking place designated as such by this Order and identified as such in Schedule 1 to this Order;

“penalty charge” means the charge set by the Council under the provisions of Section 72 of the Traffic Management Act 2004;

“permit” means any permit identified by this Order as being a valid permit for use within a parking place designated of this Order during that parking places controlled hours;

“permit holder” means a person who holds a valid parking permit;

“principal user” means the person who, not being the owner or registered keeper, is the person who is the main user of the vehicle whether or not with the consent of the owner or registered keeper;

“private hire car” means a vehicle being a motor vehicle constructed or adapted to carry fewer than 8 passengers other than a Hackney Carriage and duly licensed pursuant to Section 48 of the Local Government (Miscellaneous Provisions) Act 1976;

“private motor vehicle” means any vehicle which is not a Hackney Carriage as defined in Section 38 Town Police Clauses Act 1847 or Small Goods Vehicle as defined in Schedule 1 of Goods Vehicles (Licensing of Operators) Act 1995, nor a Large Goods Vehicles as defined in Schedule 5 of Goods Vehicles (Licensing of Operators) Act 1995;

“proprietor” means a person, partnership, company or organisation who occupy business premises situated within the boundary of the City of Cambridge;

“registered keeper” means the person in whose name the vehicle is or was at the relevant time registered under the Vehicle Excise and Registration Act 1994

“relevant position” means the manner in which a disable persons badge, parking permit, or other parking device is displayed within a vehicle when parked and shall be consistent with the manner prescribed for the display of a disabled persons badge by Regulation 12 of the Disabled Persons (Badges for Motor Vehicles)(England) Regulations 2000.

“season ticket” means a season ticket issued in accordance with Article 7 of this Order;

“ticket” means either a ticket purchased from a ticket machine at a payment parking place or taken from a pay-on-foot parking place entrance barrier or any other authorised parking device as the case may be;

“ticket machine”:

- (a) means an apparatus of a type and design approved by the Secretary of State for the purpose of this Order being apparatus designed to issue a ticket indicating the payment of charge, and the date and time at which a charge was paid, but
- (b) where every ticket machine at a parking place is out of order or where the parking place is one designated as having a ticket machine but none is installed, references to ticket machine shall at the relevant time be construed to refer to the car park attendant at the parking place from whom a ticket may be purchased;

“valid permit” means any permit issued by the Council to those identified in Schedule 11 as being eligible to apply for a permit and which is also identified by this Order as being a valid permit for a parking place designated by this Order, for which a permit is required during controlled hours;

“vehicle” means a motor vehicle as defined in this Order;

“visitor permit” means a permit issued to visitors for use in their vehicle while parked in a parking place for which a visitors permit is a valid permit, as identified by this Order;

“virtual parking permit” means an electronic record of a parking ticket, parking permit or waiver issued and confirmed by the Council to exempt a person leaving a vehicle in a parking place from the requirements in this Order to display such ticket, permit or waiver in the vehicle when left; and

“wait” or “waiting” refers to a vehicle stopping and remaining stationary for any period of time whether or not with the intention of parking and a vehicle shall be deemed to wait for any period in the same parking place (as the case may be) if any part of it is below the vehicle or the vehicle’s load (if any) whether or not the vehicle is moved during that period.

Interpretation

- (2) Except where the context requires otherwise, any reference in this Order to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
- (3) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- (4) “Include”, “includes” and “including” are deemed to be followed by the words “without limitation” and general words introduced by “other” do not have a restrictive meaning, and “for example” is not to be interpreted as if there are not other examples nor to limit or restrict the ordinary meaning of the words preceding it.

- (5) Headings are for convenience only and do not affect the construction of this Order.
- (6) A provision of this Order which is void or unenforceable shall (to that extent) be read down so as to be valid and enforceable and if it is not capable of being so read down then it shall be severed from all other provisions of this Order and the remaining provisions shall continue to have effect.
- (7) Words importing the singular or plural number include the plural and singular number respectively and words importing the masculine gender include the feminine or neutral gender and references to a person or corporation include a corporation or person respectively.

PART 2 USE OF PARKING PLACES - GENERAL

Use of parking places and parking areas

3. Each parking place or area may only be used according to the terms specified for it in this Order including the class of vehicle, the positioning of the vehicle, the maximum time limit for waiting and the days and times permitted or prohibited and on payment of the charges payable.

Manner of standing

4. Every vehicle left waiting in a parking place in accordance with the provisions of this Order shall stand so that every part of the vehicle is either:
 - (1) within the limits of a particular parking bay within the limits of the parking place or area; or
 - (2) in the absence of marked parking bays so as not to obstruct:
 - (a) the movement of either pedestrians or other vehicles gaining access or egress to or from the parking place or area; or
 - (b) any vehicle from being able to gain access or egress to or from any parking space within the parking place.

Reduction of charges for disabled person's badge holders

5. Any disabled person's vehicle which displays in the relevant position a disabled persons badge may be charged a reduced parking charge to the extent specified in Schedule 6 and 7 in respect of the parking place in which the vehicle is waiting.

Application for season tickets

6. By lodging a completed prescribed application form and tendering the prescribed fee a:
 - (1) proprietor of any business premises may make application to the Council for a season ticket in respect of a vehicle owned by that proprietor, or an employee of that proprietor, to park in a parking place for which this Order permits use of season tickets; or
 - (2) resident parking permit holders identified in Schedule 6 may make application to the Council for a season ticket to permit the vehicle for which their resident parking permit was issued to also park in the car parks

identified in Schedule 6 between the hours and on the days specified in that Schedule.

Issue of season tickets

7. On receipt of a correctly completed application in the prescribed form with the prescribed fee as indicated in Column 2, (or Column 4 for Group A vehicles) of Schedule 8 and provided that the applicant has satisfied all criteria, the Council may issue a season ticket for the nominated vehicle of an eligible applicant under Article 6 on such terms as the Council may from time to time determine.

Season ticket terms enforceable under this Order

8. The terms of the season ticket must be observed as if they were terms in this Order applying to the parking place in respect of which the vehicle is waiting and failure to observe such terms is deemed to be a contravention of this Order for which a penalty charge may be issued.

Time Limits

9. A driver shall not allow a vehicle to wait in a parking place beyond the maximum time limit as specified in Column 3 of Schedules 1, 2, 3 and 4, nor for longer than the time or period stated:
 - (1) on any ticket;
 - (2) in any season ticket terms and conditions;
 - (3) on a car club parking permit; or
 - (4) either:
 - (a) on a hand held device; or
 - (b) a record obtainable by a civil enforcement office from a service provider.

Parking only for Disabled Person's Badge Holders

10. A driver shall not cause or permit a vehicle to wait in a parking bay marked for a disabled person's vehicle unless that driver is either a disabled driver or a driver accompanying a disabled person and the vehicle displays a valid disabled person's badge in the relevant position

Compliance with entry and exit signs and markings

11. A driver shall comply with all signs and markings in a parking place that are either:
 - (1) indicating the entrance to or exit from the parking place; or
 - (2) indicating that a vehicle using the parking place shall proceed in a specified direction within the parking place.

Prohibition against obstructions

12. The driver of a vehicle using a parking place shall not obstruct access to the parking place or to any premises adjoining the parking place or obstruct the access roads within the parking place.

Stop engine in parking place or area

13. The driver of a motor vehicle using a parking place shall stop the engine as soon as a vehicle is correctly in the position in the parking place and shall not subsequently start the engine except when about to change the position of the vehicle in or to depart from the parking place.

Sounding horns

14. The Driver of a vehicle using a parking place shall not sound or permit any other person to sound any horn or any similar instrument except when necessary while parking their vehicle in the parking place or when about to change the position of the vehicle in or to depart from the parking place.

No through access

15. No person shall use a parking place as a means of passage from one road to another road.

Restrictions on use of vehicles in a parking place or area

16. It is prohibited without the written consent of the Director of **Commercial Services** of the Council or his nominee for anyone to use a parking place or to use or allow to be so used any vehicle left in a parking place:
 - (1) to undertake (or allow to be undertaken) any cleaning, maintenance or repair of a vehicle except such as may be necessary to enable the vehicle to be removed from the parking place;
 - (2) for or in connection with the sale of any goods or services to anyone in or near the parking place;
 - (3) for sleeping or accommodation or camping purposes;
 - (4) for eating or cooking purposes; or
 - (5) to use a vehicle or allow it to be used for any purpose other than the temporary leaving of the vehicle subject to the provisions of this Order.

Licensing and insurance of Vehicles

17. The driver of a vehicle shall not cause or permit that vehicle to wait in any parking place unless the vehicle is licensed in accordance with the provisions of Section 1 of the Vehicle Excise Registration Act 1994 and the driver is covered by a policy of insurance complying with the requirements of Part VI of the Road Traffic Act 1988 and that is current in respect of the use of the vehicle by that driver.

Deposit of litter

18. Littering of a parking place is prohibited.

Threatening, abusive or disorderly behaviour

19. Using any threatening abusive or insulting words or behaviour, or disorderly behaviour, displaying any writing, sign or other visible representation which is threatening, abusive or insulting towards users of the parking place (or any other parking place) or towards residents or users of neighbouring premises is prohibited.

Prohibition of structures and fires

20. In a parking place no person shall:
 - (1) erect or cause to be erected any tent stand building or other structure whether temporary or not without the written consent of the Council; or
 - (2) light or cause or permit to be lit any fire, barbeques or fireworks.

Removal and repositioning of Vehicles

21. When a vehicle waits in a parking place in contravention of any of the provisions of this Order a person authorised in that behalf by the Council may remove the vehicle or arrange for it to be removed from that parking place and when a vehicle is waiting in a parking place in contravention of the provision of Article 10 a person authorised in that behalf by the Council may alter or cause to be altered the position of the vehicle in order that its position shall comply with that provision.

Removal of Vehicles in an emergency

22. For the purpose of meeting the requirements of an emergency a person authorised in that behalf by the Council or a police constable in uniform may alter or cause to be altered the position of a vehicle in a parking place or remove or arrange for the removal of a vehicle from a parking place and in so doing shall provide for the safe custody of the vehicle.

Method of removing and repositioning Vehicles

23. A person authorised to remove or alter the position of a vehicle in Article 21 or 22 of this Order may do so by towing or driving the vehicle or in such other manner as they may think necessary and may take such measures in relation to the vehicle as they may think necessary to enable them to remove it or alter its position as the case may be.

Safe custody of Vehicles

24. When a person authorised by the Council to remove a vehicle either removes or makes arrangements for its removal under this Order they shall make such arrangements as may be reasonably necessary for the safe custody of the vehicle.

Power to close any parking place or area or part thereof

25. Notwithstanding the provisions of this Order any person authorised by the Council may by notice displayed on or near the parking place close any parking place or any part thereof for any period and may designate it or any part as reserved for use only by particular vehicles for particular purposes approved by the Council. No driver of any vehicle shall use the parking place or any part thereof when it is so closed unless with the written consent of the Council or in compliance with the particulars of reservation.

No liability for loss or damage to Vehicle or property

26. Vehicles using the parking places do so at the risk of the driver and the Council accepts no liability or responsibility either at common law or under the Occupiers' Liability Act 1957 or otherwise for loss of or damage to vehicles or other property left in parking places.

Tickets as evidence

27. The particulars specified on a ticket, or on an authorised parking device, as defined under Section 35 The 1984 Act as to the time at which a ticket was obtained from the ticket machine or at an entry barrier shall (in the absence of proof of the malfunction of the ticket machine or the entry barrier) be conclusive proof of the particulars so specified.

Application for car club parking permit

28. By lodging a completed prescribed application form and tendering the fee as identified in Column 2 of Part 2 of Schedule 8 a car club operator may make application to the Council for a car club parking permit in respect of a vehicle owned or used by that Operator to park in any parking place identified in Column 4 of that Schedule.

Issue of car club parking permit

29. On receipt of a correctly completed application in the prescribed form with the prescribed fee and provided that the applicant has satisfied all criteria the Council may issue a car club parking permit for the nominated vehicle of an eligible applicant under this Article on such terms as the Council may from time to time determine.

Car club parking permit terms enforceable under this Order

30. The terms of the car club parking permits must be observed as if they were terms in this Order applying to the parking place in respect of which the vehicle is waiting and failure to observe such terms is deemed to be a contravention of this Order.

Parking only for car club permit holders

31. Each car club parking permit parking place may only be used in accordance with this Order for waiting by vehicles displaying in the relevant position a valid car

club parking permit issued in respect of that vehicle and relating to that parking place.

Parking only for motorcycles

32. A driver shall not cause or permit a motor vehicle other than a motorcycle to wait in a parking bay marked as a motorcycle parking place.

Parking only for coaches

33. A driver shall not cause or permit a motor vehicle other than a coach to wait in a parking bay marked as a Coach parking place.

PART 3 PAY ON FOOT PARKING PLACES

Designation of pay-on-foot parking places

34. The parking places specified in Column 1 of Schedule 1 and shown as a shaded area in the plan identified in Column 2 of that Schedule are hereby designated as pay-on-foot parking places and are subject to the provisions of this Order.

Use of pay-on-foot parking places

35. (1) Pay-on-foot parking places are controlled by entry and exit barriers whereby the driver of a vehicle of a class defined in Column 6 of Schedule 1 gains entry to such parking places by taking a ticket at the entry barrier. This ticket shall be submitted to a pay station at the end of the parking period and validated by making payment in accordance with the parking charges shown respectively for the said parking places in Schedule 6. The validated ticket shall then be used to operate the exit barrier.
(2) In the event that a driver of a vehicle is unable to produce a ticket through loss or any other cause whatsoever they may obtain a validated ticket by applying to a Car Park Attendant and making a payment at a pay station at a rate which assumes that the vehicle has been in the parking place since 9.00am on the day in question.
(3) A disabled badge holder, or a vehicle with a disabled badge holder passenger, may wait in a pay-on-foot parking place free of charge for up to three hours but must pay any charge applicable for a period exceeding three hours. On submitting the entry barrier ticket to the pay station the disabled badge must be scanned to obtain the free parking period and any balance payable must be paid to validate the ticket for use at the exit barrier.

Other means of use of pay-on-foot parking places

36. The Council may introduce any form of authorised parking device to facilitate entry and exit to or from any pay-on-foot car park and to facilitate payment of the parking charge, shown respectively for the said parking places in Schedule 6, either at a payment station or through whatever other form of payment of the charge as may be determined by the Council from time to time.

PART 4 PAY AND DISPLAY PARKING PLACES

Designation of pay and display parking places

37. The parking places specified in Column 1 of Schedule 2 and shown as a shaded area in the plan identified in Column 2 of that Schedule are hereby designated as pay and display parking places and are subject to the provisions of this Order.

Use of pay and display parking places

38. The driver of a vehicle shall not permit it to wait during the charging hours in a pay and display parking place longer than the maximum time limit (if any) specified in Schedule 7 in relation to that parking place and shall not return to any part of the same parking place until at least 1 hour has passed since the end of its last use irrespective of whether or not it is the same parking bay.

Valid ticket required

39. A driver of a vehicle waiting in a pay and display parking place must have validation by way of a ticket, or authorised parking device, for the whole time that the vehicle is waiting during the charging hours. A ticket, or parking device, used in a pay and display parking place shall only be valid if it has been purchased at or before the time the vehicle commenced waiting and;
 - (2) in the case of a valid ticket, showing the payment is fully and properly made for the parking period, purchased by payment using the insertion of coins, notes or debit/credit cards in a ticket machine, it is exhibited on the vehicle in the relevant position so that the date and expiry of the parking period may be observed from outside the vehicle; or
 - (3) in the case of a virtual parking permit, purchased by payment using a method not requiring the insertion of coins, notes or debit/credit cards in a ticket machine and provided that the payment is fully and properly made for the parking period as indicated by:
 - (a) a record appearing on a hand held device; or
 - (b) a record being obtainable by a civil enforcement officer contacting the service provider.

Grant of a virtual parking permit

40. A virtual parking permit may be obtained by any of the methods provided from time to time by the Council and to be valid must be registered on an account in an electronic database approved by the Council.

Evidence of payment of the parking charge

41. Subject to Article 42, if at any time while a vehicle is left in a pay and display parking place designated by this Order and there is no valid parking ticket exhibited on the vehicle in a relevant position or there is no indication that payment of the charge for a parking ticket has been made using the virtual parking permit system, or there is an indication in either case that the parking period for which payment was made has expired, it shall be presumed, unless the contrary is proved, that either;

- (1) the charge for the parking period has not been duly paid in respect of that vehicle; or
- (2) the parking period for which payment was made had already expired.

Exceptions to payment of the pay and display parking charge

42. (1) The drivers of vehicles waiting in accordance with the provisions of this Order during the charging hours in a pay and display parking place who have either been issued or granted for that parking place:

- (a) a season ticket;
- (b) a waiver;
- (c) a car club parking permit while being parked in a car club permit parking space; or
- (d) any other authorised parking device for that parking place; and have either:

- (i) displayed the season ticket, waiver, car club parking permit or any other authorised parking device in the relevant position so that the details on the face of the parking device can be read from outside the vehicle; or
- (ii) caused a record of such season ticket, waiver, car club parking permit or other authorised parking device; to either:
 - (a) appear on a hand held device; or
 - (b) to be obtainable by a civil enforcement officer from the service provider;

shall be exempt from the requirement to make a payment on waiting in the pay and display parking place under Article 41 of this Order.

(2) Where all the ticket machines at the said parking place carry notices placed upon them by a person duly authorised by the Council indicating that they are out of order and no Car Park Attendant is in attendance at the parking place the driver of a vehicle shall be exempt from the payment of the parking charge;

PROVIDED THAT the vehicle does not remain in the parking place for longer than the maximum time limit as specified in Column 3 of Schedule 2 (if any) allowed in the parking place.

Restriction on removal of ticket or any other parking device

43. No one other than the driver of the vehicle or a person authorised by the Council shall remove a pay and display parking place ticket, season ticket, waiver, car club parking permit or other authorised parking device from a vehicle unless authorised to do so by the driver.

Contravention of pay and display parking places

44. The waiting of a vehicle in a pay and display parking place other than in accordance with this Part is prohibited.

PART 5 PERMIT PARKING PLACES

Designation of permit parking places

45. Each permit parking place which is described in Column 1 of Schedule 3 and shown as a shaded area in the plan identified in Column 2 of that Schedule is hereby designated as a permit parking place and is subject to the provisions of this Order.

Times of operation of permit parking places

46. Each permit parking place specified in Schedule 3 may be used for parking during its controlled hours, as specified in Column 3 of that Schedule, only by the class of vehicles identified under Column 6 with a valid permit issued in respect of that vehicle and that parking place, as identified under Column 4 of Schedule 3 and subject to the conditions set out in Column 5 of that Schedule, which is either:
 - (1) displayed in the relevant position in such a way that the details on the face of the permit can be seen from outside the vehicle; or
 - (2) recorded on a database so as to cause a record of the permit:
 - (a) to appear on a hand held device; or
 - (b) to be obtainable by a civil enforcement officer from the service provider.

Exemptions for disabled badge holder vehicles

47. The failure to possess, or display a parking permit shall not prohibit any disabled person's vehicle displaying a valid disabled person' badge in the relevant position from waiting during the controlled hours in any permit parking place.

Contravention of permit parking places

48. The waiting of a vehicle in a permit parking place other than in accordance with this Part is prohibited.

PART 6 FREE OFF-STREET PARKING PLACES

Designation of free parking places

49. Each free parking place which is described in Column 1 of Schedule 4 and shown as a shaded area in the plan identified in Column 2 of that Schedule is hereby designated as a free parking place and is subject to the terms of this Order.

Use of Free parking places

50. (1) Use of free parking places other than for parking of vehicles of the class referred to in Column 5 of Schedule 4 during the operational hours and for the maximum stay as specified in Column 3 of that Schedule and in accordance with any provisions set out in Column 4 of that Schedule and subject to the provisions of this Order is prohibited.
- (2) Nothing in Article 50 (1) above shall prohibit a car club permit holder vehicle from parking in a parking bay marked for car club permit holders.

PART 7 OFF-STREET GARAGE FORECOURT PARKING PLACES

Designation of garage forecourt parking places

51. Each garage forecourt parking area which is described in Column 1 of Schedule 5 and shown as a shaded area in the plan identified in Column 2 of that Schedule is hereby designated as a garage forecourt parking place and is subject to the terms of this Order.

Use of garage forecourt parking places

52. No person shall permit a vehicle to wait on a garage forecourt parking place as specified in Schedule 5 to this Order, such forecourt to include the access road to enable vehicles to access to or exit from a garage forecourt parking place, other than for the time reasonably necessary for their vehicle to gain access to or egress from their own garage parking space, being a garage parking space provided by the Council to a local resident vehicle owner, or let by the Council to a vehicle owner, under the terms of an agreement for the use of the garage space.

Restricted areas within garage forecourt parking places

53. Any area within the garage forecourt parking place marked with yellow hatch markings, or any side of an access road to or from a garage forecourt parking place marked with double yellow lines, will be considered a restricted area for the purposes of this Order and waiting in these areas is prohibited at all times, even for vehicles entitled to use a garage space accessible from that garage forecourt parking place or access road.

Contravention of garage forecourt parking places

54. The waiting of a vehicle in a garage forecourt parking place, which includes the access road to a garage forecourt parking place, as specified in Schedule 5 to this Order other than in accordance with this Part is prohibited.

PART 8 CONTRAVENTION AND PENALTY CHARGE

Contravention

55. (1) Where a contravention of this order constitutes a parking contravention within the meaning of The Act of 2004, or successor legislation, the contravention shall be subject to the penalties and procedures provided for by that legislation.
- (2) Where a contravention of this order constitutes a parking contravention within the meaning of The Act of 2004 a penalty charge is payable for each calendar day or part thereof that the vehicle is in contravention of this Order by the owner and the vehicle may be removed by or on behalf of the Council in accordance with the provisions of the Act of 2004 and of this Order.

(3) A contravention of this order which does not constitute a parking contravention within the meaning of The Act of 2004, or successor legislation, is an offence under section 35A(1) of the 1984 Act.

Removal of vehicles

56. Where a Civil Enforcement Officer has removed or caused to be removed a vehicle in accordance with Article 55(2) above:

- (1) he/she shall provide for the safe custody of the vehicle;
- (2) the Council shall be entitled to recover from the owner, or the person responsible, such charges as provided by the Act of 2004 in respect of the removal, storage and disposal of the vehicle; and
- (3) the provisions of the 1984 Act as amended shall apply to the disposal of such vehicles removed by or on behalf of the Council pursuant to this Article.

PART 9 REVOCATION

Revocation of all Orders

57. The City of Cambridge (Off-Street Parking Places) Order 2016 and any amending Orders are hereby revoked.
