Homelessness & Rough Sleeping Strategy 2021-26: Consultation

Cambridge City Council is developing a strategy for tackling homelessness and rough sleeping. Rough sleeping and begging are visible outcomes of homelessness. However, homelessness affects far more people than we see on the streets of our city. There are also individuals and families who do not have a settled home to call their own, and who are in precarious temporary accommodation. Many families are feeling the effects of COVID-19 on their livelihoods, and may be more at risk of homelessness now, as a result.

We want to consult people who live and work in the city about our strategy to deal with the problem, and about the actions we propose to take. We have designed a set of questions to gather your views on the key issues.

 - 5. To prevent rough sleeping;
 - 6. To break the cycle of chronic and repeat street homelessness.

Preventing homelessness

We already prevent homelessness in a lot of cases when people tell us they are likely to lose their home. Below are some additional actions that we are proposing, in order to try and increase the number of people we can help to remain in their homes. More detail can be found in the Strategy.

8. We want to support those at risk of homelessness to remain in their homes where possible, or to find a new home without an intervening period of homelessness. The specific actions we propose within our Action Plan, to improve our chances of achieving this, include:

1. To develop further our specialist support and advice to private tenants who are being evicted;

2. To create a publicity campaign, to encourage those faced with homelessness to contact us at an earlier stage;

3. To develop further our mediation role, when someone is asked to leave by family or friends;

4. When someone has been asked to leave by family or friends, to explore incentives to allow them to remain long enough to achieve a managed move;

5. To reconsider our work with young people, with a focus on the most vulnerable, in order to improve their understanding of housing availability and choices;

6. To analyse the costs and benefits of setting up a 'private sector tenancy rescue scheme' - making loans or grants to tenants with arrears, to help them stay in their home;

7. To work with partner housing associations to understand patterns and causes of evictions;

8. To ensure the Council continues to understand the economic impact of COVID-19 on working, or formerly-working households.

Helping people to find suitable accommodation

Where homelessness cannot be avoided, we want to support people to access a range of long-term affordable accommodation options.

10. In order to achieve this objective, these are the main actions that we are proposing:

1. Launch a publicity campaign aimed at encouraging private landlords to offer accommodation to the Council's housing advice customers;

2.Consider further financial incentives for private landlords, including lump-sum advance rent payments;

3. Introduce further incentives to encourage homeless families to take up a private rented sector offer;

4. Seek to use low demand Council and housing association 3 bedroom properties for 2 single sharers, through Town Hall Lettings;

5. Seek suitable long-term empty homes, and empty commercial properties for conversion into housing for those in need

12. Temporary or emergency accommodation, although sometimes necessary, is not ideal for most people. It also tends to be expensive for the Council. The actions we are proposing, to try and minimise our use of temporary and emergency accommodation, are:

1. Seek to keep people in current accommodation for as long as possible;

2. Review demand for temporary accommodation provided by social and specialist providers every quarter, to ensure we are able to meet needs, and are keeping hotel placements to a minimum;

3. Reduce long-term occupation of temporary housing;

4. Use contacts made during the COVID-19 'Everyone In' effort, to source alternative emergency accommodation (including market purchase), especially for households whose high needs make standard provision unsuitable.

Minimising rough sleeping

The Council has had a long-term target of keeping the number of people seen sleeping rough in the city to less than 10, but has struggled to get close to this target. This issue has increased in prominence in recent years. Many who are seen sleeping rough have complex needs such as mental health issues, and/or drug and alcohol dependence. We want to improve support to rough sleepers to get them off the streets, and support them to want to (and to be able to) stay in safer, settled accommodation.

14. We want to improve access to, and effectiveness of the support services that are specific to rough sleepers. We are proposing the following actions:

1. Establish a working group with social services and health services, to agree a common approach to cases of complex mental and physical health needs amongst rough sleepers;

 Further develop and better integrate the vital work carried out by voluntary services in supporting rough sleepers and people with a street background;
Review the scope and effectiveness of move-on advice and support offered within hostels.

16. We want to reduce rough sleeping, and reduce some of the 'pull factors' that can encourage people to remain on the street, and not engage with housing and support services. We are proposing the following actions:

1. Review how we respond to begging and street-based anti-social behaviour, to inform an Enforcement Strategy;

2. Set demanding targets for the average duration of a period of rough sleeping, and the average time to achieve an offer of a home;

3. Look at how we deal with rough sleepers on the streets of Cambridge who have no connection with the City;

4. Critically review the Housing First programme so far (purpose-built, custodianassisted housing);

5. Provide 17 modular homes for single homeless people.
