Dear Gerri

The site is on Fen Road. It is currently occupied by vacant single storey buildings in poor condition. The buildings previously housed a scheme for people with Learning Difficulties. The scheme closed in 2019 and the residents have been rehoused. The scheme was managed by a supported housing provider funded by Cambridgeshire County Council; the lease on the site is held by Metropolitan Thames Valley Housing Association. The freehold is owned by Cambridge City Council. Following the closure of the scheme MTV have indicated that if agreement can be reached they would surrender their leasehold interest.

The leasehold interest was originally for 125 years; there are 98 years remaining. The rent is a peppercorn but there are restrictions on the use of the site. Although less than 30 years old the properties on the site suffer from significant disrepair and maintenance issues. The properties also do not make full use of the potential of the site. An initial capacity study for 14 homes has been drawn up.

Morning Fiona

To assist the Council's purchase of 71-73 Fen Road, on 15 May we instructed a topographical and underground utilities survey to confirm the location of utilities under the site. This included surveying the area immediately surrounding the site including Fen Road, the adjacent passage and the area to the north of the site, to ensure all utilities affecting the site were accurately located. The surveyors were given a Google Earth image with a red line and were told the boundaries of the survey. Having spoken with a Partner in the surveying firm this morning, they have apologised and are seeking more details of the conversation but emphasised that their only role was completing a survey and they are not aware of any development proposals.

The Council's development proposals are restricted to the boundaries of 71-73 Fen Road and any mention of extending this boundary has no factual basis – if the surveyor did make such a comment this that individual's ill-informed opinion and poor judgement.

We apologise for the grief that this misunderstanding must have caused to those affected.
