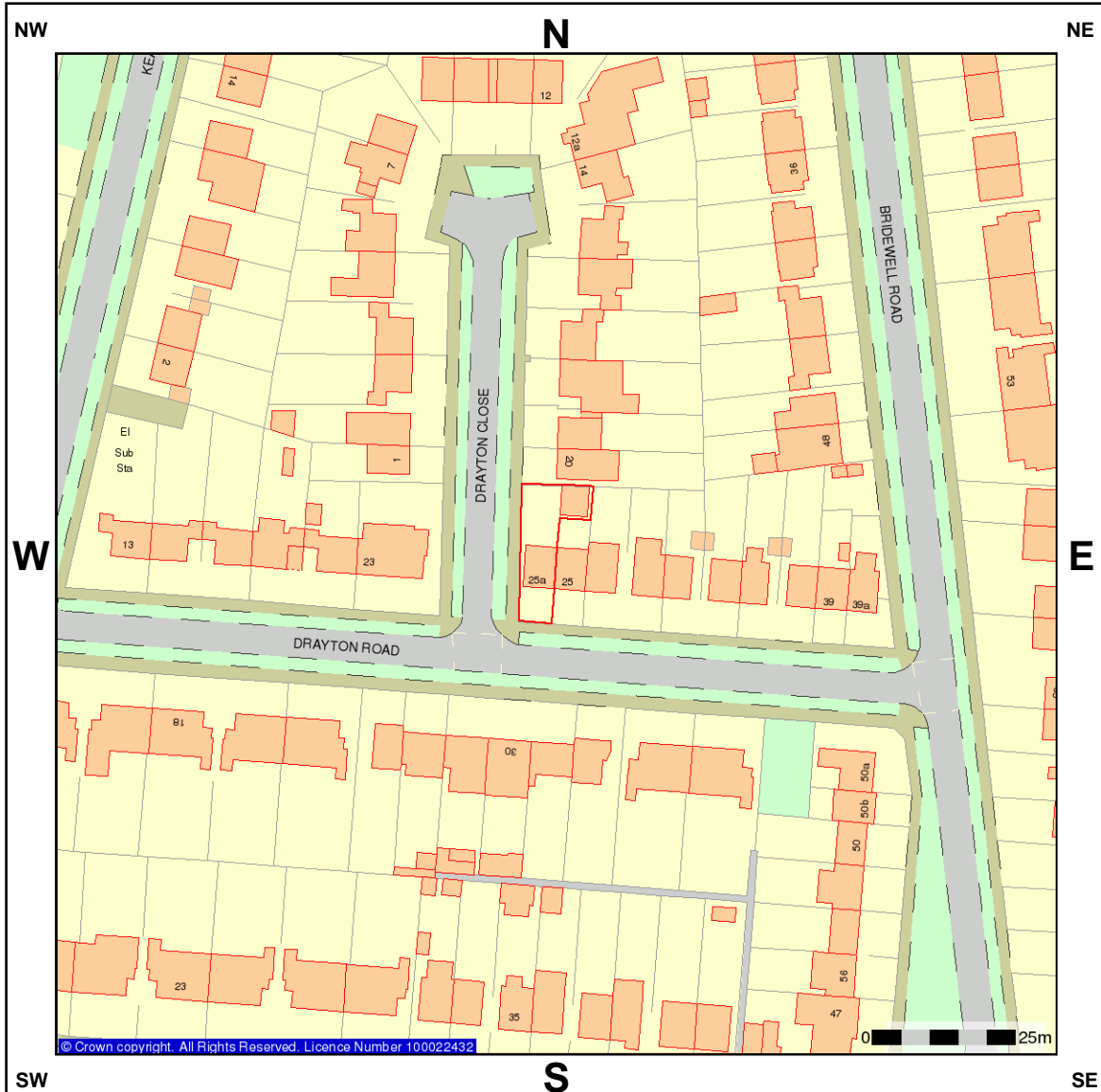

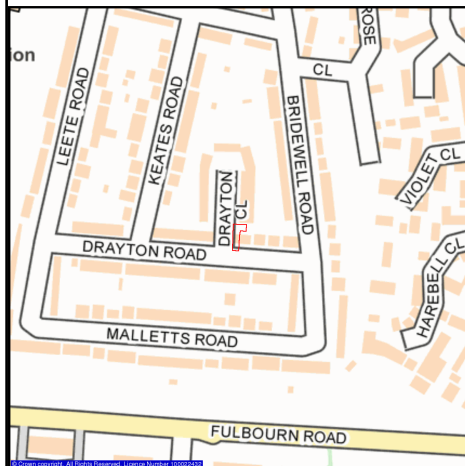


Map Legend
