I hope the following will answer your query:

1. Any and all details of the Conveyance(s) of December 1891 regarding the acquisition of land now forming St Matthews Piece;

We have made searches of our Legal Services miscellaneous document index and deed store and have not found any information in relation to this property.

We also reviewed the council's property terrier database and found some outline information relating to the parcels of land that make up St Matthews Piece and the surrounding areas. Additional information relating to these areas were also found in a response the council made to an FOI in 2014, which I have used as the basis of the information disclosed.

There are 3 entries from the 19th century on the property terrier relating to land that make up St Matthew's Piece and surrounding areas – these are marked on the attached maps and data held on the property terrier.

F/DB00029 – purchased in 1891

F/DB00034 - purchased 1892

F/DB00057 – purchased 1898

We have also made searches for the file reference RWC/PR/SA/1/42 (marked as Covenant on the attached map). This file reference is for a legal file which was destroyed in 2018 in line with the council's retention schedule. The notes on the council's property terrier state *"NOT CITY OWNED BUT THERE IS A COVENANT PREVENTING ANY DEVELOPMENT ON THIS OPEN SPACE Ref: RWC/PR/SA/1/42"*

As the original parcel of land that makes up St Matthews Piece was split between the open space and the land on which the Howard Mallet Centre was built when the northern section was acquired by Cambridgeshire County Council you may wish to request whether any information relating to the land is held by them. 


same land (St Matthews Piece) was gifted by the Cambridge Commons Committee to the Mayor of Cambridge in June 1898
