We consider that disclosure of this information under Freedom of Information would be a breach of this confidence.

In considering this exemption the council has considered the wider public interest in relation to the transparency of our processes for awarding and monitoring grant funding.

We use checks and balances of grant funding applications and the process of agreeing them and this is why we are maintaining the exemption and cannot therefore disclose the information

We are satisfied that our processes offer transparency over the awarding of grant funding.

We have therefore decided to uphold the decision to apply the exemption from disclosure under section 41 of the Freedom of Information Act.
