Greater Cambridgeshire waste service has not, but this is also a question for the county council

As a waste collection authority we have a standing remit to decrease the amount sent to disposal and or landfill. We have currently 3 ways of doing this. 1. Increasing the amount we collect for recycling and composting (so provide this service and encourage the use of it) and 2. Driving behaviour change toward waste reduction. (How residents can make better choices to buy less or choose reusable items etc... thereby through less away) We are big advocates of the Love Food Hate Waste campaign, as an example. 3. Though our collection policies e.g limiting the amount of general rubbish we collect and limiting additional bins etc, which also helps encourage recycling.
