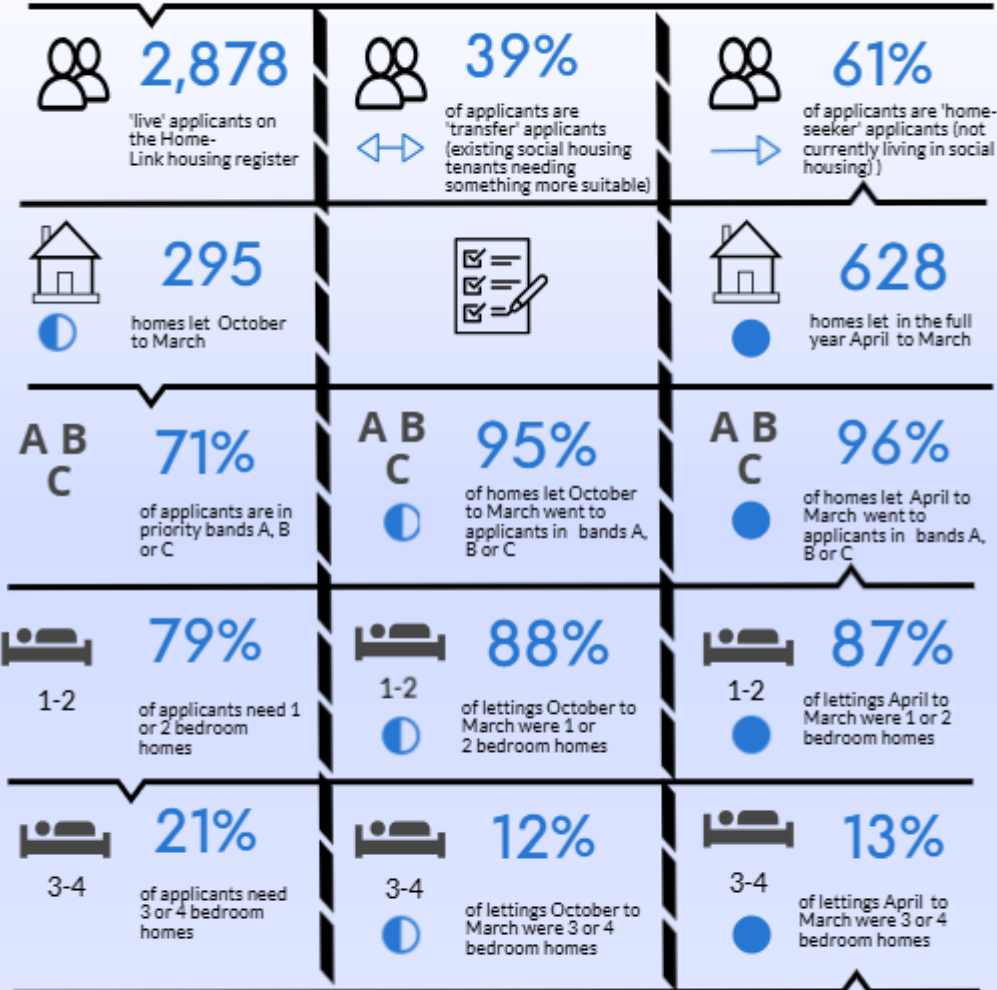

## Housing Register Applications & Lettings Summary

March 2025



## Applications and Lettings: Summary

- There are **2,878** 'live' applicant households on the housing register
- **39%** of applicants are 'transfer' applicants (existing social housing tenants needing something more suitable)
- **61%** of applicants are 'homeseeker' applicants (not currently living in social housing)
- **295** homes were let October last year to March this year
- **628** homes were let last April to March
- **71%** of applicants are in priority bands A, B or C
- **95%** of homes let October to March, and **96%** of homes let last April to March went to applicants in bands A,B or C
- **79%** of applicants need 1 or 2 bedroom homes
- **88%** of lettings October to March, and **87%** of lettings last April to March were 1 or 2 bedroom homes.
- **21%** of applicants need 3 or 4 bedroom homes
- **12%** of lettings October to March, and **13%** of lettings last April to March were 3 or 4 bedroom homes.

## Applications and Lettings: Commentary

- There remains high demand for social housing, with demand far out-stripping supply.
- Lack of supply compared with demand is reflected in numbers of housing register applicants having risen steadily over the last five years. There is emerging evidence nationally that the number of private rental home may be reducing, with numbers of rentals coming onto the market falling and some private landlords reportedly withdrawing from the market. This, together with other factors such as ongoing issues with the economy may contribute towards further increases in demand going forward.
- Numbers of lettings over the last three full financial years were higher than in the previous years, due partly to the number of new-build homes becoming available, including through the council's own house-building programme.

- The gap between the number of applicants and the number of homes becoming available homes has narrowed slightly this year due to the higher number of lets. However, in March this year there were still over four times more applicants on the register than homes let during the year to that date. It remains the case that some applicants may never be housed.
  - The main demand over recent years has been for one-bedroom homes, and the majority of lets are also of one & two bedroom homes.
  - Around one fifth of applicants on the register need three & four bedroom homes but a smaller proportion of those sizes of home have become available over recent years, and during April to September this year, compared with applicant demand.

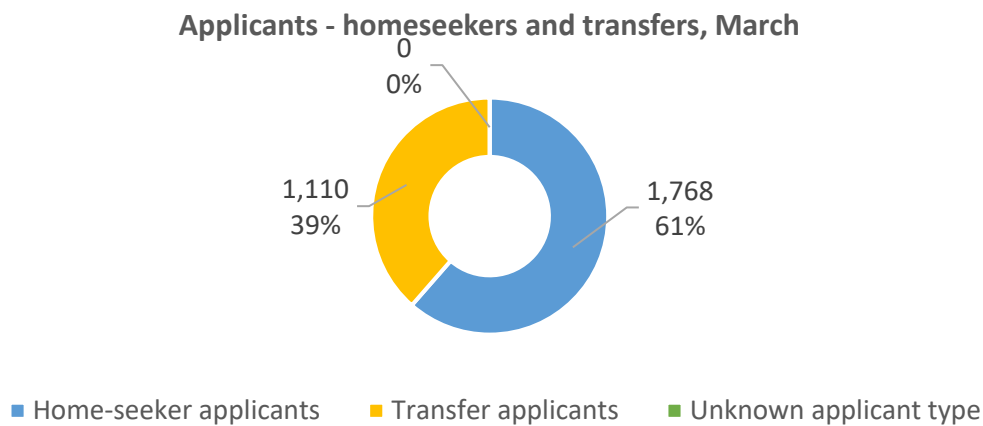

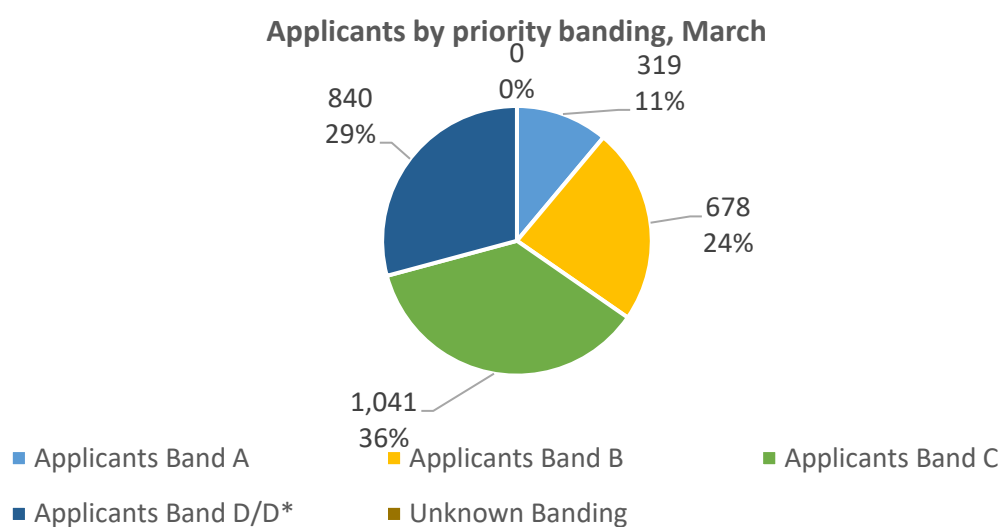

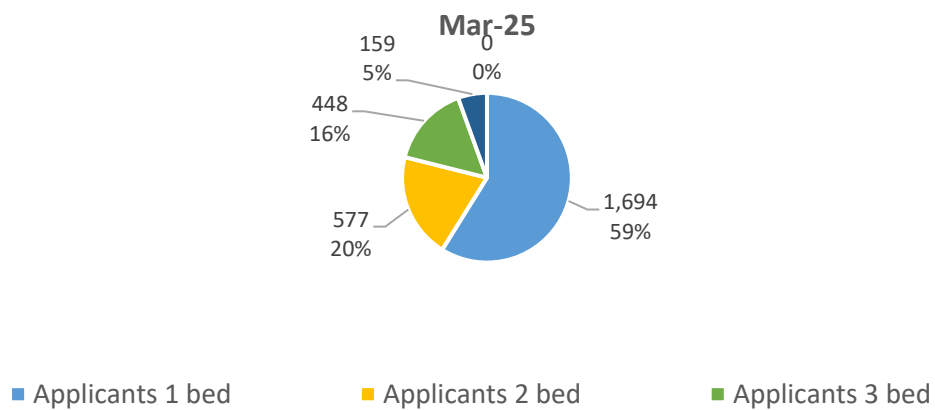

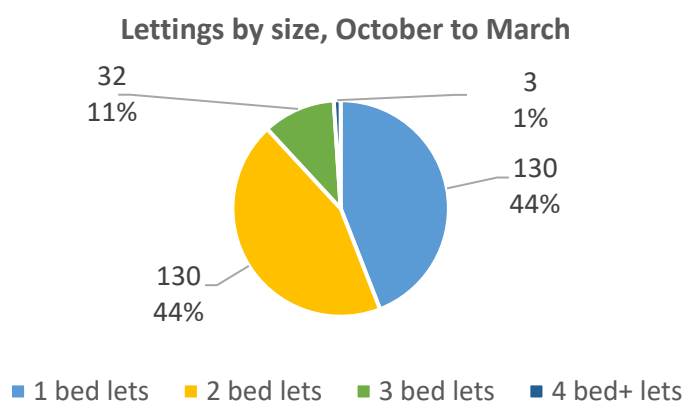

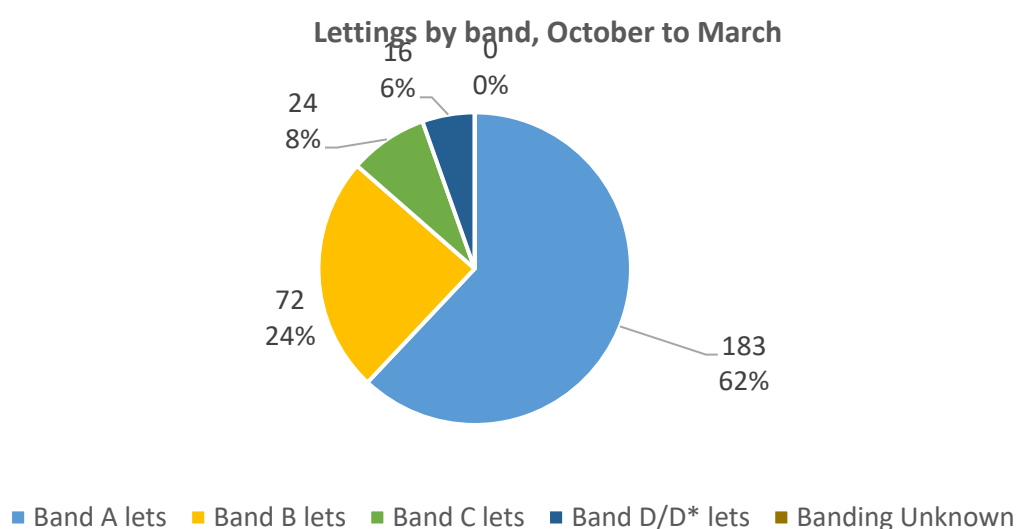
