APPLICATION FOR TENANCY OF A COUNCIL GARAGE

Applications for Council owned garages are accepted from anyone, but some applicants have priority status. Variable charges apply (please see separate Garage Charge Sheet). **Garage rents will be collected by Direct Debit.**

Garages can be rented for storage of a motorised vehicle or for general storage purposes, but variable charges apply, depending upon the required use.

Applications are normally dealt with in date order but the Council reserves the right to give priority to anyone suffering from a disability which limits their walking ability.

Please note: - Garages will **NOT** be offered to Council tenants who are in rent arrears, and should your home tenancy fall into arrears the Council may serve notice to recover your garage tenancy.

The Council are not liable for the contents of let garages.

An inspection of the garage shall be carried out within 10 working days of your tenancy ending, and should the garage not be left empty or in a clean condition you may be charged.

Non Council Tenants. A deposit of £50.00 is payable prior to the commencement of the garage tenancy and is returnable at the end of your tenancy should the garage be left empty and in a clean condition. Garage rents will be collected by Direct Debit.
